In addition to the main files some of the CM papers are kept in pockets (e.g. Suez, Panama, etc.)

As many of the Division's files contain technical information which may be required for reference purposes for many years the procedure to be followed when they are put away (P/A) has been agreed with the Record Officer. (Part IIB of the Staff Manual refers).

When files are sent to P/A they may be stored away from the office and will normally be available within 48 hours.

The ~~MM~~ files will be retained for as long as the vessel to which they relate remains on the British Register.

Some time after a vessel leaves the British Register Archives Section will refer all the files and related pockets to the Surveyors and request final instructions as to disposal. If the Surveyor recommends that a particular file is of outstanding technical or historical interest the papers will be conserved under the provisions of the Public Record Acts.

It has been found that some files in the MNA and MS series used by the Engineer Surveyor-in-Chief's Branch and the Chief Ship Surveyor's Branch should be retained for up to 25 years.

Where a MNA or MS file contains technical details, reports or specifications the certificate at the bottom right hand corner of the file should be signed by a Professional or Technical Officer at the time of P/A. The certificate should indicate the length of time that the file should be retained and the reason (e.g., Lifeboat Specification: Retain 20 years, or Dangerous Goods: Retain indefinitely). If necessary such a file may be kept in the Division or at the Public Record Office. In the latter case it should be available for a short period of time for reference.

Files, other than those mentioned above, should be retained for a period of time after the date of the last action. The date of P/A will help Archives staff to identify files.
